e-Statement Enrollment Reward

1. Login to SRU FCU Online Banking and select the Statements tab.
2. Select "Start e-Statements."
3. Receive your \$5.00 Reward in your Share Savings!

*Once enrolled, you will no longer receive paper statements or notices, however, you may revert to the paper format at any time.

Refer-a-Friend Reward

1. Share the Love! Refer a friend for membership at SRU Federal Credit Union.
2. Complete our Refer-a-Friend sheet and give it to a friend or family member to provide to us at account opening.
3. Once your friend or family member opens an account, your \$5.00 Reward will be deposited into your Share Savings, and best of all, there is no limit to the amount of referral reward credits you can earn!

*Referred member must live, work, worship, or attend school in Slippy Rock, or be a relative of an active SRU FCU member in order to qualify for membership. Referred member must be the primary accountholder for a reward to be issued.

Limited time offer. Certain restrictions apply. Must be at least 18 years old and have an active SRU FCU membership in good standing in order to qualify for Rewards. Offer is subject to change without notice. Employees, Officials, and their families are not eligible for this promotion. Cash rewards will be credited to your Share Savings account the month following e-Statement enrollment or new account opening if all requirements are met. The fair market value of rewards in excess of \$600.00 will be reported to the IRS on form 1099.

IN CASE OF ERRORS OR QUESTIONS ABOUT YOUR STATEMENT

If you think your statement is wrong, or if you need more information about a transaction on your statement, write us on a separate sheet of paper at the address shown above as soon as possible. We must hear from you no later than 60 days after we sent you the first statement on which the error or problem appeared. You can telephone us, but doing so will not reserve your rights.

In your letter, give us the following information:

1. Tell us your name and account number (if any).
2. Describe the error or the transfer you are unsure about, and explain as clear as you can why you believe there is an error or why you need information.
3. Tell us the dollar amount of the suspected error.

MEMBER STATEMENT
